ENA does not allow children under the age of three years old to participate in the gymnastics part of the party. This is for the safety of the child. Please do not ask us to bend the rules.

If the number of children told to ENA is over 14 we will provide 2 teachers. Therefore, no matter how many children come on the day of the party you will be charged for the 15 minimum. For one teach the minimum is 10 children.

The cost is \$14.00 per child. A \$40.00 **NON-REFUNDABLE** deposit is required upon reserving your party. The balance is due on the day of the party. If you would like to pay with cash, please bring exact change. Gratuity is not included.

For safety reasons, parents will not be permitted in the gym during the party, except for the host parents who may take pictures and videos after signing the Release on the back of this Contract. If parents will not abide by this rule then the party will be stopped and the parents asked to leave. It is the party's responsibility to warn all of their guests that there is an inherent risk in doing gymnastics. Any activity involving height, flight, and/or rotation of the body, such as gymnastics, increases the risk of accidental injuries. More information is provided on the following page.

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT  
("AGREEMENT")

I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the Activity.

I hereby release, discharge, and covenant not to sue Seikunas Gymnastics Incorporation, d/b/a Eastern National Academy its affiliates and its management, its respective administrators, directors, agents, officers, volunteers, and employees, other participants, and sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) from all liability, claims, demands, losses, or damages, on my account caused or alleged to be caused in whole or in part by the negligence of the "releasees" or otherwise, including negligent rescue operations and future agree that if, despite this release, waiver of liability, and assumption of risk, I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any loss, liability, damage, or cost, which any may incur as the result of such claim.
